

Build America Buy America Self-Certification List for the Broadband Equity Access and Deployment (BEAD) Program

Overview:

Manufacturers that have invested in the domestic manufacturing of equipment – in order to comply with the Build America Buy America (BABA) preference for the Broadband Equity Access and Deployment (BEAD) Program – are concerned that they will be undercut by companies falsely claiming BABA compliance. In order to address such concerns, the Department of Commerce is publishing and maintaining this list of manufacturers where an officer of the company has certified that certain company equipment meets the domestic manufacturing requirements listed in the BABA waiver for the BEAD Program.¹

Such officers of the companies on the list are aware that false certifications are subject to fine or imprisonment under the Program Fraud Civil Remedies Act (31 U.S.C. § 3801 et seq.) and the False Claims Amendments Act of 1986 and the False Statements Accountability Act of 1996 (18 U.S.C. §§ 287 and 1001, respectively).

Instructions:

Companies below have certified certain equipment they sell meets the domestic manufacturing requirements enumerated in the BABA waiver for the BEAD Program and can be considered compliant with the Buy America preference. Click through each company's link below to view specific equipment information.

Information from manufacturers will include:

- **Product Name:** Provide the specific name of the piece of equipment
- **Product Identifier:** Reference the specific product ID (e.g. SKU)
- **Product Description:** What it is or what it does
- **Location of Manufacturing:** City & State
